Legislative Updates: (provide by MASA)

Macomb ISD is leading a multi-district lawsuit seeking injunctive relief ahead of the November 30 deadline for districts to accept or decline Section 31aa funds in the FY 2025-26 School Aid budget. Several districts have signed on as additional plaintiffs. The suit was filed in both the U.S. District Court for the Eastern District of Michigan and the State of Michigan Court of Claims, challenging that the language violates clauses of the U.S. and State of Michigan Constitutions respectively.

Since the budget passage in October, districts and legal counsel have **raised significant concerns** with the new language tied to dedicated school safety and mental health funds. Under the statute, any district accepting 31aa funds must agree to comply with an investigation of a "mass casualty event," a term left entirely undefined in law. This ambiguity, combined with questions about waiving immunity and expanding liability exposure, has created substantial legal risk for districts considering acceptance of the funds. Additionally, the statute is not limited to the FY 2025-26 school year, raising concerns about long-term implications.

Despite ongoing conversations with lawmakers, a legislative fix remains unlikely, leaving litigation as the only viable path forward. The federal case raises constitutional questions under the Fifth and Fourteenth Amendments, arguing that the law was improperly enacted and that the plaintiffs have standing to challenge the provision. Procedurally, school districts must file against the state superintendent as the responsible authority.

If an injunction is granted before November 30, the 31aa funds will be held until a decision is made on the merits of the case. **If no injunction is issued by that date**, the state will need to **determine whether the funds are included in the December state aid payment**.

District Updates:

Football Stadium:

Plans for the football stadium are progressing. Concept drawings are being completed which will feature:

- -a north entrance featuring bathrooms, concessions, and an outdoor grilling area
- -home bleachers on the west side of the field with team rooms, an official's room, training room, and storage under the bleachers.

GDK is currently working on pricing to make sure the concept fits within our budget.

Interviews are being scheduled for turf companies.

West and Heights:

Administrators were able to tour a local Elementary School to look at furniture options. New furniture will be purchased this year for Heights and Phase 1 of the West project.

Special Board Meeting:

A special board meeting will be held on Monday, November 24th at 5:00pm. The first item on the agenda will be a discussion of 31aa funds and a possible resolution if the district decides to accept those grant funds. Board interviews will begin at 5:30pm in the board training room.
